

Dumbleyung Swimming Pool Update

The Shire of Dumbleyung continues to undertake important project planning activities to progress with the Dumbleyung Swimming Pool Redevelopment Project.

At a Special Council Meeting held in July, endorsement was given to a Development Application (DA) prepared for an Option 1 project proposal. A copy of these DA plans are attached for information.

Having a Council endorsed DA is a pre-requisite for any proposal submitted through the new Growing Regions Program facilitated by the Federal Government.

The Growing Regions Program is a two-stage process with the first stage requiring an eligible Expression of Interest (EOI) to be prepared and submitted by no later than 1st August 2023. The Shire project team has successfully met this lodgement deadline.

The EOI submission seeks circa \$2.665M in Growing Regions Program grant funding towards the swimming pool redevelopment project (out of a total estimated capex cost of circa \$5.4M).

We now await formal feedback on whether our submission has been successful or otherwise. If successful, the Shire will be invited to lodge a full application (stage 2) which closes on 12th December 2023.

The Growing Regions Program is a competitive fund, so no guarantees of success – but we have to be in it, to win it!

The Shire was unable to secure approval from the Federal Government to extend the use date of previously earmarked LRCI grant funding (circa \$857K) past 30th June 2024, thus the change in focus towards the Growing Regions Program.

Work is also progressing on a State Government grant funding submission into this year's round of the Community Sporting & Recreation Facilities Fund (CSRFF), which closes on 30th September 2023.


Shire CEO Gavin Treasure recently met with the State Government Minister for Sport & Recreation's office to raise awareness and discuss the project in advance of a formal grant funding submission.

A project fundraising strategy has also been adopted by Council targeting the following three key areas: CBH Grain Drive, Crowdfunding and Major Mining & High Net Wealth Individuals.

Work will commence on actively pursuing these fundraising opportunities in line with project development activities.


