This is presented to a community group making an extraordinary contribution to the community, delivering outstanding work on an event, project, or for a cause and may recognise outstanding service over a number of years.



### 2026 Citizen of the Year Nomination Criteria

The Shire of Dumbleyung Australia Day Awards celebrate the achievements and contributions of individuals and community organisations or groups within the Shire of Dumbleyung local government area. These awards are an honour the Shire of Dumbleyung and Council can bestow to publicly acknowledge our local community members, whose dedication and contributions may otherwise go unnoticed.

This information is to assist in the completion of the Shire of Dumbleyung 2026 Citizen of the Year Nomination Forms.

### **Award Categories**

- · Citizen of the Year
- Community Group of the Year

### Citizen of the Year

### Eligibility Criteria

To be eligible for Citizen of the Year Award:

- Nominees should be a ratepayer or reside or work principally within the Shire of Dumbleyung local government area
- Awards may be granted posthumously in recognition of recent achievements
- Groups or couples will not be eligible
- A person may receive the award on more than one occasion in recognition of their particularly outstanding community contribution or involvement in an alternative initiative
- Unsuccessful nominees may be nominated in future years
- Nominations must be apolitical in their nature and should not in any way bring the local government into disrepute
- Sitting members of State, Federal or Local Government are not eligible.

### Selection Criteria

When considering nominations for this award, the selection panel shall have regard to the following criteria:

- Has the nominee made an outstanding contribution to the community;
- Has the nominee been an inspiration/role model to the community;
- Has the nominee shown achievements in community activities, academic, sporting, personal, cultural, environmental and/or social responsibility; and
- Has the nominee demonstrated a commitment to enhancing the welfare and wellbeing of the community, which has benefits to others?



### **Community Group of the Year**



### Eligibility Criteria

To be eligible for the Community Group of the Year Award, nominees must:

- Be a not-for-profit organisation that provides opportunities for the community to participate and contribute to social, economic and cultural life
- Bring recognition and credit to the community through a cultural, environmental, economic or sporting achievements within the Shire of Dumbleyung local government area
- Community Groups must be within the Shire of Dumbleyung local government area
- Awards may be granted posthumously in recognition of recent achievements
- A group may receive the award on more than one occasion in recognition of their particularly outstanding community contribution or involvement in an alternative initiative
- Nominations must be apolitical in their nature and should not in any way bring the local government into disrepute.

### Selection Criteria

When considering nominations for this award, the selection panel shall have regard to the following criteria:

- Has the group made an outstanding contribution to the community;
- Has the group empowered or been an inspiration to the community;
- Has the group shown achievements in community activities, academic, sporting, personal, cultural, environmental and/or social responsibility; and
- Has the group demonstrated a commitment to enhancing the welfare and wellbeing of the community, which has benefits to others?

### **How to Complete Your Nomination**

Nominations must be submitted on the official Shire of Dumbleyung 2026 Citizen of the Year Nomination Forms attached.

Please ensure you provide as much information as possible, the Selection Panel can only consider the information listed within the nomination form and any supporting documentation, not what the selection panel may know about the nominees.

Additional details can be included in separate attachments e.g. copies of other awards or supporting documents such as photos, newspaper or magazine articles about the nominee and their achievements.

Failure to provide complete information may result in the nomination not being considered.





### **Selection Process**

Following close of nominations, the Shire of Dumbleyung Selection Panel (consisting of current Elected Members) will select award recipients based on the Selection Criteria at a Council Confidential Information Session.

A nomination in a category may not result in an award being presented in that category, if the nominee/s does not meet the Selection Panel criteria.

The decisions of the Shire of Dumbleyung Citizen of the Year Award Selection Panel are final, and no additional correspondence will be entered in to.

### **Award Ceremony**

All nominees will be sent a letter informing them that have been nominated for one of the awards, and award recipients will be announced at the official Australia Day Event held on Australia Day annually.
