CATOWNER'S RESPONSIBILITIES

The Cat Act 2002 states cat owners must ensure their cat;

- Wears a collar displaying the owner's name, address and council registration tag when in a public place.
- Is sterilised, micro-chipped and registered with the Local Council oncethey reach six (6) months of age. Failure to comply may lead to penalties.
- Is under the control of a competent person.
- Is kept inside the property as prevention to wildlife endangerment.
